GUARANTEE

A one year guarantee shall commence upon completion of the work, provided payment as been received in full by Grand Canyon. In addition to the one year guarantee you may thereafter, at your sole option, as long as you own the property, renew this guarantee annually for the cost of \$ 125.⁰⁰. After the third year, from the date of treatment, and each year thereafter, Grand Canyon reserves the right to revise the annual renewal charge.

Grand Canyon will at no extra cost apply any necessary treatment to the premises if reinfestation of subterranean termites is found therein during the period of the guarantee. After the first year, failure to pay the renewal fee on or before the due date shall at the option of Grand Canyon be sufficient cause for termination of the guarantee. Grand Canyon reserves the right to inspect the property annually.

DUE TO THE NATURE OF CONSTRUCTION AND/OR THE EXTENT OF EXISTING DAMAGE AND/OR APPLICATION RESTRICTIONS, THIS AGREEMENT DOES NOT GUARANTEE AGAINST PRESENT OR FUTURE DAMAGE TO PROPERTY OR CONTENTS, NOR PROVIDE FOR REPAIRS OR COMPENSATION THEREOF.

In the event of additions to the identified property, Purchaser must give prior notice and arrange with Grand Canyon for additional service at the Purchaser's expense. Such additions or alterations may also require an adjustment to the annual renewal charge.

Upon transfer of ownership of the identified property, this guarantee plan may be continued upon the request of the new owner. In addition, Grand Canyon reserves the right to revise the annual renewal charge upon transfer of ownership. In the event the new owner fails to request continuation of this guarantee plan or does not agree to pay the annual renewal charge, the guarantee plan will terminate automatically as of the date of the change of ownership with no further notice.
